Clearly and unfortunately - the answer to this question is - "**YES!**"
Unfortunately, it does appear that the majority of those who do populate our contemporary *political community-at-large* have **no** ability, and worse yet - **NO DESIRE** - to be able to discern - "Right from Wrong!"

They have become dislodged from and have **NO** mooring to, anything above and beyond themselves, whereby they can seek wisdom and a direction or course, to help them navigate through their corruptible human deficiencies and weaknesses.

One of the important collective similarities which our Founding Fathers, and consequently, through them, America was blessed with, was that almost every Founding Father was a Believer in God and His Son, Jesus Christ. All were bound by the spiritual Biblical moral-restraints of God and America was birthed by men with the kind of Honor and Character which is conspicuously lacking in the majority of those in our contemporary political community-at-large today!

If today's, "*Liberal-Left Ruling Class Statist's*," will concede even a little credibility to our Founding Fathers, it should be at least that, [they] had the **Right** to define what they meant and believed when they said it; and also that their ideals and beliefs were validated – "They did what they said!"

They **fought** the War, they **wrote** the Constitution and they **formed** and **established** the government!

Collectively, one of our Founding Fathers greatest reservations about installing a **Representative Republican** form of government was that they realized that because there would be **So Much individual freedom** – history had shown that a republic could easily become a democracy and they quickly slide into tyranny.

The hope they had to prevent that from happening was that America was predominantly – **Christian** in faith. They believed that, because the Christian, by virtue of their belief in obedience to God, was already capable of governing themselves individually – might then also, be able to govern collectively according to those same individual restraints – the American Republic.

I believe that George Washington's, perspective, wisdom and belief – has as much importance and validity **TODAY**, as when he did profess it – because what he said has come to fruition and is True! - **He was Right!**

Please consider some excerpts from George Washington's "Farewell Address."

Washington's Farewell Address, 1796

Friends and Citizens:

The period for a new election of a citizen to administer the executive government of the United States being not far distant, and the time actually arrived when your thoughts must be employed in designating the person who is to be clothed with that important trust, it appears to me proper, especially as it may conduce to a more distinct expression of the public voice, that I should now apprise you of the resolution I have formed, to decline being considered among the number of those out of whom a choice is to be made.

*...Of **all** the dispositions and habits which lead to **political prosperity**, **religion** and **morality** are **indispensable supports**. In vain would that*

man claim the tribute of patriotism, who should labor to subvert these great pillars of human happiness, these firmest props of the duties of men and citizens. The mere politician, equally with the pious man, ought to respect and to cherish them. A volume could not trace all their connections with private and public felicity. Let it simply be asked: Where is the security for property, for reputation, for life, if the sense of religious obligation desert the oaths which are the instruments of investigation in courts of justice? And let us with caution indulge the supposition that morality can be maintained without religion. Whatever may be conceded to the influence of refined education on minds of peculiar structure, reason and experience both forbid us to expect that national morality can prevail in exclusion of religious principle.

I do not believe that diversity is an attribute. I do not welcome the Muslim, the Hindu, the Buddhist, or the Atheist or Humanist the spiritual or religious realm – where American rule-of-law is to be determined or decided! America was clearly founded upon the Bible and Christianity and I do not welcome any of ***another religion's*** moralities, or specific religion-driven laws, to be a part of that which is recognized by *my* American government or our Judiciary or legislative processes thereof.

While I am able to converse with *Libertarians* on fiscal issues regarding government restraint and responsibilities; I find that I am unable to believe that *Libertarians* can ultimately run American government any better than the *Liberal-Left Ruling Class Statist* – because without the one important common and singular unifying foundation of only a ***"Single Truth"*** – that being a core moral strength of God – the *Libertarian* will too, at some point, come undone and unable to hold to an agreed purpose, without waiver.

Again, if you believe George Washington to have wisdom and to have an authority to represent a valid opinion on such matters, as they pertain to America – I would recommend that you read *again* from his "Farewell Address," exactly how he perceived the need for what I have just iterated.

If, the Republic is to succeed – it must be governed by an identifiable and recognizable and consistent immovable and foundation of ***"Absolute Truth!"*** ***Sir William Blackstone***, a preeminent English jurist, wrote ***"Blackstone's Commentaries on the Laws of England, (1765)"*** which was a central resource to our Founding Fathers as they wrote and established the Laws for America. One easily recognizable influence was his view of ***"The Laws of Nature and of Nature's God"*** which can be observed then from our, "Declaration of Independence."

Let us consider some of the perspective on Law (from Blackstone) which our Founding Fathers did actually rely upon and incorporate into the "Declaration of Independence," "Constitution" and the "Judiciary" of America:

... "Man, considered as a creature, must necessarily be subject to the laws of his Creator, for he is entirely a dependent being ...And, consequently, as a man depends absolutely upon his Maker for everything, it is necessary that he should in all points conform to his Maker's will. ...this will of his Maker is called the law of nature."

... "These laws laid down by God are the eternal immutable laws of good and evil, ...This law of nature dictated by God himself, is of course superior in obligation to any other. It is binding over all the globe, in all countries, and at all times: no human laws are of any validity if contrary to this."

... "The doctrines thus delivered we call the revealed or divine law, and they are to be found only in the Holy scriptures, [and] are found upon comparison to be really part of the original law of nature. Upon these two foundations, the law of nature and the law of revelation, depend all human laws; that is to say, no human laws should be suffered to contradict these."

Those who govern America today are only "Good" according **"their"** ever-flexible and always relevant, perception of what is, "Right or Wrong." Contrarily, Sir William Blackstone and our Founding Fathers believed that there **was** an absolute to **Right** or **Wrong** and that, if government or man, were ever to drift away from that absolute – a re-calibration could be made – Because, "Natural Law," the, "Law of Nature" and the *God of Nature* – **NEVER** changes; **NEVER** varies; **NEVER** is subordinate to any other Law!

Question: If you are "Law-abiding," would you find comfort and a sense of security in entering a courtroom where you **knew** what the law was – and even more importantly – that it was always the same and did not change!

The strong religious and moral fabric which was common and that did bind our more than 250 Founding Fathers together enabled them to agree on a source and foundation for American Law that was absolute and consistent!

The wisdom and goodness of that which our Founding Fathers implemented did work and did endure – up until the time when we now do experience the

results of *worldly-wisdom*, as it is dispensed, by the *Liberal-Left Ruling Class Statists!*
